Contracts can also be hand delivered to Jenny Kwon, Redeemer Day School's Director. Children will not be re-enrolled until the enrollment fee is paid. **Contracts received after January 16, 2018 do not guarantee space for your child(ren) for the 2018 – 2019 school year and he/she will be considered a part of the regular admission process.**

Statement of Parent or Guardian

In signing this Re-enrollment and Tuition Contract, I re-subscribe to the following school policies:

1. The school has full discretion in the grade placement of students.
 2. The school reserves the right to request the withdrawal of any student who does not meet a standard of conduct conducive to a safe and orderly learning environment.
 3. The school reserves the right to dismiss any student who fails (or whose parents fail) to cooperate with school policies.
 4. School records including progress reports are released only when all of the student's accounts are current.
 5. Students will not be allowed to attend school unless accounts are kept current.
 6. Christian education is a cooperative undertaking between the school, parents, and student. Consequently, the educational philosophy, objectives, and policies of the school must receive the support of both parent and student at and away from school. The lack of such support may be grounds for not being permitted to re-enroll and, in extreme cases, for dismissal from school.
 7. I make a commitment to attend conferences, Parent-Teacher Fellowships and workshops.
 8. I understand the mission and values of Redeemer Day School and subscribe to them fully.
 9. I agree to participate in my child's formal education by participating in school activities.

2018 - 2019 Re-Enrollment & Tuition Contract

In signing this Contract, I understand and agree to adhere to the following Tuition Policy:

1. The annual tuition is due in two equal payments, April 15, 2018 and October 1, 2018 and is non-refundable. There is no grace period, and a late fee of \$50 will be charged for late payments.
 2. The Re-enrollment and Tuition Contract must be signed and returned and the enrollment fee paid before a child is considered enrolled at Redeemer Day School.
 3. The parents/guardians signing this Contract accept responsibility to keep their financial obligations current without invoice.
 4. In signing the Re-enrollment and Tuition Contract, I assume responsibility for all tuition and fees for the full school year and acknowledge that my obligation is unconditional. Withdrawal, absence, or dismissal does not release me from my obligation to pay the full amount of the annual tuition. Acceptance of the terms of this contract commits me to one full school year's tuition.
 5. Only under one of the following three circumstances may a family request, in writing, an exception to this non-refundable tuition policy:
 - 1) The child is moving outside the Atlanta metropolitan area (more than 30 miles away from the school). The Director must be notified of the child's withdrawal in writing prior to August 1, 2018 and the resulting opening must be filled on or before August 15, 2018. If these conditions are met, the parents/guardians signing this contract will be refunded a maximum of 50% of the April 16th payment and will be released from further financial obligation.
 - 2) The child is professionally diagnosed and documented with a special need that cannot be met by Redeemer Day School as determined by the Director.
 - 3) If a child is withdrawn from Redeemer Day School to be enrolled in a private school or lottery based charter school that goes through elementary grades, and the Director is notified in writing by May 1, 2018, the parents/guardians signing this contract will be released from financial obligation.
- The Board of Trustees retains the ultimate discretion regarding the granting or denial of any such requests and, if the request is granted, the percentage of tuition which may be refunded.
6. A \$50 fee will be charged for checks returned for insufficient funds.

In signing this Contract:

1. I hereby give permission for my child to participate in all field trips and extracurricular activities authorized by Redeemer Day School.
2. I hereby give my permission for pictures taken of my child during any school activity to be used by Redeemer Day School for publications and on the website.
3. I hereby authorize and grant permission to the School to hospitalize and/or secure treatment for my child (or ward) in case of medical or surgical emergency, provided the School is unable to reach me. I hereby release Redeemer Day School, its successors and assigns, and those acting with permission and upon its authority, from any liability, responsibility, or claim that may arise by reasons of any exercise of the authority granted above. All responsibility of a child's medical expenses while at Redeemer Day School are assumed by the parent/guardian.
4. I agree to provide a health form indicating immunizations, which must be completed and returned to the School prior to the first day of school in order for my child to enter the School.
5. I hereby release and indemnify Redeemer Day School, its officers, directors, teachers, and agents from any liability or damage arising as a result of injuries to my child while attending school or a school function or while being transported to or from school or a school function.
